

TERMS AND CONDITIONS OF USE

1. Consumer Protection

 - If you are an entity, you are not listed on any restricted lists, and you are not directly or indirectly owned or controlled by any person listed on such lists.

8. Updates and Modifications

- a. We reserve the right to update or modify these terms and conditions at any time. Changes will be effective immediately upon posting to our website. It is your responsibility to review these terms periodically for any updates.
- b. Your continued use of the Site or Services after the posting of the amended Terms constitutes your acknowledgment and agreement to abide by the modified Terms. If you object to any modifications, you may terminate your use of the Site and/or Services.

9. Applicable Law and Jurisdiction

These terms and conditions shall be governed by and construed in accordance with the laws of the State of Florida, United States. Any dispute arising out of or related to these terms and conditions shall be resolved exclusively in the state or federal courts located in Florida.
